I apply to be considered for nomination and selection to the New Zealand Team to compete at the Gangwon 2024 Winter Youth Olympic Games ("Team") in the sport of:

In applying to be considered for inclusion in the Team, I acknowledge, agree and declare that:

- a. I have read the NZOC Nomination and Selection Regulation via the NZOC website <u>https://www.olympic.org.nz/assets/Selection-Regulation-December-2021.pdf</u> (and any amendments to this document) and, once confirmed, my National Federation's Nomination Criteria for the Gangwon 2024 Winter Youth Olympic Games ("Games"), via my National Federation's or the NZOC website <u>www.olympic.org.nz</u>. I agree to comply with and be bound by the terms outlined in these documents and any amendments to this document.
- b. My application will be considered and determined in accordance with the NZOC Nomination and Selection Regulation. In particular, I acknowledge that any right of appeal and the process for such an appeal in relation to nomination or non-nomination or selection or nonselection must be exercised in accordance with the NZOC Nomination and Selection Regulation (including any subsequent amendment to this document), unless otherwise agreed in my National Federation's Nomination Criteria for the Games.



- c. As a condition of my nomination to the Team, I must complete and execute (in the manner and by the time instructed by the NZOC), an Athlete Agreement which will come into effect only if and when I am confirmed as selected to the Team by the NZOC.
- d. The decision whether or not to nominate me to the NZOC for consideration of selection to the Team is subject to quota restrictions, the Nomination Criteria for my National Federation and the NZOC Selection Policy, and is at the sole discretion of the NZOC.
- e. In the event that the National Federation nominates me to the NZOC for selection to the Games Team, I understand I am not guaranteed to be selected. The decision whether or not to select me to the Games Team is subject to the NZOC Selection Policy and is at the sole discretion of the NZOC.
- f. I am a New Zealand citizen and I hold a New Zealand passport.
- g. I am a member of my National Federation or a member of one of its affiliated organisations (e.g. a member club).
- I acknowledge that I am bound to the Sports Anti-Doping Rules (as may be amended from time to time) made by Drug Free Sport New Zealand through membership of my National Federation and/or the NZOC's Integrity Regulation, and to the anti-doping rules of my International Federation and any subsequent amendments to those documents.
- i. I have not used any substances or methods included on the Prohibited List, which is published annually by the World Anti-Doping Agency and which, if detected as being present in a sample provided by me for anti-doping purposes, could constitute an anti-doping rule violation.
- j. I have not committed any other breaches of the Sports Anti-Doping Rules or the antidoping rules of my International Federation and there are no anti-doping rule violation proceedings in process or pending against me.
- k. I am not currently suffering any physical or mental impairment that might prevent me from competing in the Games to the highest possible standard.
- I. I have met any eligibility requirements of my International Federation and the IOC for participation in the Games and will fully complete the Games Organising Committee entry and eligibility form, prior to the date specified by the NZOC.
- I remain in good standing with my National Federation and I am not currently under disqualification or suspension under the rules of any National Federation, International Federation, the NZOC or the IOC and there is no disciplinary process pending against me.
- n. I *have not been* convicted of a criminal offence. I further declare that no charge in respect of any criminal offence punishable by a term of imprisonment is pending against me.



- o. I agree to the collection of personal information about me, including my name, contact details, sport, size of clothing, biographical details, photos and associated imagery, the results of any health/medical examinations undertaken to assess my fitness and any other medical information reasonably required to ensure optimal health strategies are able to be facilitated for entry to, or participation at, the Games, and the usage and storage of such information by the NZOC at its offices or through its data systems and in the case of health and medical information, High Performance Sport New Zealand data systems, for the purposes of consideration of my potential entry, accreditation and participation at the Games or future games.
- p. In accordance with the NZOC Long List Acknowledgement of Athlete Anti-Doping Responsibilities attached in Schedule A, I agree to the disclosure of personal information about me (as set out in paragraph o. above), to Drug Free Sport New Zealand, including, but not limited to, my name and contact details being provided to Drug Free Sport New Zealand, initially by NZOC and further upon request from Drug Free Sport New Zealand, for the purpose of locating me for testing no later than 19 July 2023 (or such extended date as agreed by the NZOC Board).
- q. I also agree to the disclosure of personal information about me (as set out in paragraph o. above) to the Games Organising Committee or other agencies for the purpose of providing potential entry information, applying for accreditation (including background and security checks) and reservation of quota places.
- r. I understand and acknowledge that the Games Organising Committee may not be required to protect the information in a way that, overall, provides comparable safeguards to those provided under the Privacy Act 2020. I also understand the Games Organising Committee may share such information with third parties, including, but not limited to, the IOC, International Federations, Broadcasting Rights Partners and Marketing Partners of the IOC, and other such third parties as required by their respective operations in connection with the Games.
- s. I will notify the NZOC of any changes to my contact details as set out above or other personal information collected. I understand any failure by me to do so may be to my detriment if Drug Free Sport New Zealand is unable to locate me for anti-doping purposes, such as testing, according to the information I have provided. It may also affect any communication regarding the Team which will be notified to the contact details provided.
- t. I have read and understood my responsibilities outlined in the NZOC Long List Acknowledgement of Athlete Anti-Doping Responsibilities attached in Schedule A.
- u. I have been invited to take independent advice on the terms of this Athlete Application and its implications, and I have been given reasonable opportunity to do so.

Schedule A – NZOC Long List Acknowledgement of Athlete Anti-Doping Responsibilities

Background

The New Zealand Olympic Committee (NZOC) only includes athletes to the Games Team who have fully complied with the NZOC Integrity Regulation, in particular the Anti-Doping requirements in Part A. This requires all athletes that are to be considered for inclusion by their National Federation to agree in writing to be bound by the Sports Anti-Doping Rules (SADR), no later than six months before the date of the commencement of the Games.

Therefore, the Long List is provided to Drug Free Sport New Zealand (DFSNZ) by the NZOC, no later than six months before the date of the commencement of the Games, in order to identify potential Games representatives to be considered for inclusion in DFSNZ's annual testing programme, in the lead up to a Games event.

Athlete Anti-Doping Responsibilities

- 1. I understand that it is my responsibility to ensure that I am informed and updated about the rules that govern my sport, and the rights and responsibilities I have with regards to anti-doping in sport. In particular, this includes:
 - Complying with requests for testing;
 - Checking the status of any medication or supplements;
 - Undertaking anti-doping education with DFSNZ;
 - Always informing medical practitioners that I am an athlete who could be subject to testing; and
 - Reporting any suspicious doping activity I become aware of to DFSNZ and/or the NZOC.
- 2. I understand that I can access information directly through the DFSNZ website (<u>www.drugfreesport.org.nz</u>) and/or DFSNZ Freephone 0800 DRUG FREE (378 437) or by contacting my National Federation.
- 3. As an athlete included on the NZOC's Long List, I consent to the NZOC sharing my personal details with DFSNZ at least six months prior to the Games for the specific purpose of being able to locate me for out-of-competition testing and other anti-doping requirements specified under the SADR, such as education, and after such time, upon request by DFSNZ.
- 4. I understand that prior to inclusion in any Games Team in any capacity, including as a travelling or non-travelling reserve, if I am prescribed a medication that contains a prohibited substance, I must apply to DFSNZ for a Therapeutic Use Exemption in advance of taking the medication (except in a medical emergency). Such Therapeutic Use Exemptions may also be required to be submitted to the IOC or relevant International Federation for the purpose of participation in the Games.
- 5. I understand that I am responsible for ensuring the personal details I provide to the NZOC, for their and DFSNZ's purposes, are accurate and up-to-date at all times.



- 6. I understand I am obligated to comply with a request for testing as and when required, and to fully cooperate with the testing process. Failure to comply with the testing process may constitute an anti-doping rule violation, which may result in me being banned from sport.
- 7. As an athlete who is a member of a National Federation that has agreed to the SADR, I understand that I can be tested by DFSNZ anywhere and anytime (regardless of whether or not I am included on the NZOC's Long List).
