In applying to be considered for appointment to the Team, I acknowledge, agree and declare that:

- (a) I have read and understood the NZOC Nomination and Selection Regulation via the NZOC website <a href="https://www.olympic.org.nz/assets/Selection-Regulation-December-2021.pdf">https://www.olympic.org.nz/assets/Selection-Regulation-December-2021.pdf</a> and any amendments to this document, and I agree to comply with, and be bound by, the terms outlined in this document and any subsequent amendments to this document.
- (b) My application will be considered and determined in accordance with the NZOC Nomination and Selection Regulation. I understand that I am not guaranteed to be appointed and there is no right of appeal against a decision of the National Federation to recommend me or not recommend me to the NZOC as Team Support, nor is there any right against any decision of the NZOC regarding the appointment or otherwise of me as Team Support.



- (c) If the NZOC accepts my Team Support Application, I understand that as a condition of any appointment, I must complete, sign and return in the manner and by the time instructed by the NZOC, a Team Support Agreement which will come into effect only if and when I am appointed by the NZOC to the Team. I will also fully complete the Gangwon 2024 Winter Youth Olympic Games ("Games") Organising Committee entry and eligibility form, prior to the date specified by the NZOC.
- (d) I am a New Zealand citizen, New Zealand resident or have the appropriate authority to enter New Zealand, if necessary.
- (e) I am:
  - (i) a member of the National Federation;
  - (ii) a member of an affiliated organisation (e.g. a member club) of the National Federation;
  - (iii) a staff member of the National Federation (i.e. I have an employment agreement); or
  - (iv) a contractor of, or provider to, the National Federation (i.e. I have a contract for service).
- (f) I acknowledge that I am bound to the Sports Anti-Doping Rules, and any amendment to such Rules, made by Drug Free Sport New Zealand through membership or contract with my National Federation and/or the NZOC's Integrity Regulation, and to the anti-doping rules of my International Federation, if any.
- (g) I have not committed any breaches of the Sports Anti-Doping Rules or the anti-doping rules of the NZOC or any International Federation and there are no anti-doping rule violation proceedings in process or pending against me.
- (h) I am in good standing with my National Federation and I am not currently under disqualification or suspension under the rules of any National Federation, International Federation, the NZOC or the IOC, and there is no disciplinary process pending against me.
- (i) I am not currently suffering any physical or mental impairment that might prevent me from partaking appropriately in the Games.
- (j) I have not been convicted of a criminal offence. I further declare that no charge in respect of any criminal offence is pending against me.
- (k) I agree to the collection of personal information about me, including my name, contact details, sport, size of clothing, biographical details, photos and associated imagery, the results of any health/medical examinations undertaken and details for, and results of, police vetting, and the usage and storage of such information by the NZOC at its offices or through its data systems and in the case of health and medical information, High Performance Sport New Zealand data systems, for the purposes of consideration of appointment by the NZOC and my potential entry, accreditation and participation at the Games or future games.
- (I) I agree to the disclosure of personal information about me (as set out in paragraph k. above) to the Games Organising Committee or other agencies for the purpose of applying for accreditation (including background, police vetting and security checks).



- (m) I understand and acknowledge that the Games Organising Committee may not be required to protect the information in a way that, overall, provides comparable safeguards to those provided under the Privacy Act 2020. I also understand that the Games Organising Committee may share such information with third parties, including, but not limited to, the IOC, International Federations, Broadcasting Rights Partners and Marketing Partners of the IOC, and other such third parties as required by their respective operations in connection with the Games.
- (n) I will notify the NZOC of any changes to my contact details as set out above or other personal information collected.
- (o) I have been invited to take independent advice on the terms of this Team Support Application and its implications, and I have been given reasonable opportunity to do so.
