## 2021 AGM Board Appointments Paper

#### **Board Appointments**

There were two positions open this year – one Elected and one Appointed.

As set out in the Constitution, the Boards Appointment Panel (made up of the Chair, an independent expert and Sport NZ appointed member) appoints the Appointed Member and recommends to the members the preferred Elected Member candidate.

### **Elected Members**

Laura Hedley is the recommended candidate for the vacant Elected Board member position. Laura is General Manager Cardrona & Treble Cone Experiences, previously Head of People & Performance for Cardrona and Treble Cone. Laura has only completed 1 year on the board as she had to re stand for election due to constitutional requirements as she replaced a retiring board member for the remainder of their term (we are now recommending this section of the constitution be updated to prevent this situation arising in future). Laura has been an invaluable member of the board. Examples of the skills and contribution Laura has made over the past year are:

- Chairing our new People and Culture Committee
- Overseeing the development of new Health and Safety Policies
- Advice to the CEO on health and safety, wellness and employment matters
- Advice and support in relation to organisational culture development
- Board representative on the athlete "SALT" group and leading initiatives around ensuring athletes have stronger connections to the board

These skills are essential for the future composition of the board, in particular given increases emphasis on wellness in sport.

The Board Appointments Panel therefore strongly recommends Laura Hedley for election to the members. Further information regarding Laura's experience and candidacy are available here.

## **Appointed Members**

We are pleased to announce that Mark Vivian has been appointed to the Board as recommended by the Board Appointments Panel.
